# **Recommendation 5:**

*Description:* Opening Doors Unlocking Potential (ODUP) is an annual, state-wide professional development institute for professionals and families who support students who are deaf and hard of hearing. For the past 17 years, ODUP has offered an in-person event, in Richmond, bringing together professionals and parents from across the Commonwealth of Virginia to engage in dialogue, discussion, and learning methods to strengthen academic outcomes for children who are deaf and hard of hearing. Participants can have a positive impact on a student's educational process by increasing their knowledge and skills regarding deaf education. The registration fee for a Virginia Public School professional is \$200.

Hanover County Public Schools will send at least one staff member from their Deaf and Hard of Hearing Department to the ODUP conference annually, beginning with the 2023 conference. The attendee(s) will be responsible for attending sessions and gathering data on how to best support deaf/hard of hearing children and will report back to their team/staff by the beginning of the following school year.
